Graffiti Removal Authorization

I (We), _____ the owner(s) of the property located at (main property) _____, San Rafael, California, or agents representing the property owner, hereby authorize the City of San Rafael and its officers, agents, contractors, employees and volunteers, also referred to herein as "City workers," to remove graffiti from said property, and that methods of removal may include but are not limited to chemical solvents, steam cleaning, painting, hydro blasting or sand blasting. I understand that graffiti removal will take place between the hours of 8am and 6pm and that City workers will do their best to notify me before they commence work.

I hereby release and hold harmless the City of San Rafael, its officers, agents, contractors, employees and volunteers from any and all claims, demands, causes of action or obligation whatsoever arising out of or relating to entry on this property for the purpose of graffiti eradication, whether or not such injuries or damage are due to the active or passive negligence of the City and/or City workers, and including, but not limited to, those arising from injuries to persons or incidental damage to shrubs, plants and other vegetation, as well as those related to the appearance of the property as the result of the graffiti eradication work.

I understand that the City workers will repaint only the area where the graffiti is located, including, in the sole discretion of the City workers, such minor areas around the graffiti as may be easily incorporated for the purpose of better camouflaging the graffiti eradication work. I further understand that every effort will be made to match existing colors; however, an exact match might not be provided. I also understand that I can furnish the paint with the color I desire if I want to be assured that I will be satisfied with the color of paint being used.

PLEASE CHECK THE APPROPRIATE RESPONSE(S):

- I will be able to supply paint or other removal equipment. Contact me to finalize the arrangements.
- I will not be able to supply paint or other removal equipment and understand that paint used by the City might not match the existing color.
- I agree to remove the graffiti myself and will do so on or after the date listed below and within 10 days of this notice. (City Code 8.35.070)
- I will participate in group graffiti removal event on _____ date and time.

REPEATED GRAFFITI REMOVAL AUTHORIZATION:

I further authorize the City of San Rafael graffiti crew and employees to remove graffiti from the property referenced above as and when it might reappear *for up to one year after the date of signing*. I understand that this authorization can be rescinded by me at any time, and that I may voluntarily renew this form annually at any time upon written notice of such rescission or renewal being delivered to the City at the address referenced below.
